# III. Purpose of data processing and consequences of failure to provide information:

#### IV. Legal basis for data processing

#### V. Recipient of your data

In the course of the competition, the organizers will deliver your data to the following recipients:

#### **1.** Members of the jury

At the end of the submission period the eight members of the jury will be informed of the first and last name as well as the submitted entries to conduct the selection of the winners\*. All members of the jury are reminded that the data may only be used for the purpose of the event and must be destroyed at the end of the event.

#### 2. The public

The contributions of the winners\* will be publicly available in printed publications, online and on social media. If necessary, the respective participants will be asked in due time to give their consent.

#### 3. Press

The first and last names and, with their consent, a portrait photo of the award winners\* will be passed on to local and regional media representatives for the purpose of press coverage.



#### VI. Duration of storage

- 1. After the end of the competition, i.e. about one to two months after the end of the last communication of the results, the first and last names, e-mail addresses and addresses of the participants will be deleted and respectively destroyed
- **2.** Except for those contributions which can be implemented and will therefore be further processed

### VII. Your rights

- You have the right to obtain information from the University of Freiburg about the data stored about you and/or to have incorrectly stored data corrected
- 2. You also have the right to have your data deleted or to restrict or object their processing.
